## **RULES AND REGULATIONS FOR USE OF READINGTON TOWNSHIP FIELDS AND PICNIC AREAS**

1. Availability of athletic fields and picnic groves shall be governed by Township use and physical condition of the playing field or picnic area. The group using the facility is responsible for clean up of the area.
2. The use of alcoholic beverages, other foreign substances or foul language is prohibited. Permits for beer and wine are available for picnics only from the Township Clerk.
3. In case of inclement weather or poor field conditions, prior permission may be withdrawn. Notification of this condition will be found by calling the Readington Recreation Office at (908) 534-9752 after 4:30 PM on weekdays and after 9:00 AM on weekends. Readington Recreation staff are authorized to ask you to leave the premises if found on the field under these conditions.
4. Termination of said contract may occur if and when renovation of the fields or picnic areas is needed.
5. All food concession monies and fees will be deposited into the Readington Township Recreation Trust Account unless otherwise authorized by the Director of Recreation.
6. Whenever the facility is to be used the following regulations apply:
  - Usage hours are dawn to dusk for Pickell Park Gazebo/Picnic Grove and for the following parks: Cornhuskers, Hillcrest, Pickell, Summer.
  - The supervisor in charge of the activity must be present before the activity is due to begin and remain with the group until all have left.
  - Parking is permitted only in legally designated areas of the parking lot. Entrances to fields and concession area must not be blocked by a parked vehicle.
  - All fees must be forwarded to the Director of Recreation and made payable to Readington Township Recreation.
  - It is understood that in all cases Readington Recreation activities have first preference in scheduling of activities.
  - Cancellation of an event by contracted party must notify the Director of Recreation as soon as this information is available.
  - All national and state laws, local ordinances and rules of the police and fire departments regarding public assemblies must be strictly complied with.
  - User will be required to include the following statement on fliers, posters or other publicity for an event: *This event is not sponsored by Readington Township Recreation and any questions should be directed to (name and phone number).*
  - A certificate of liability insurance in the amount of \$1,000,000 and naming Readington Township and Readington Township Recreation as additional insured is required before use of the facility by caterers, businesses or athletic teams.
  - Tennis courts are open until 10:00 PM. Tennis court lights are turned off at 10:10 PM to allow you to safely depart from the area.
  - The lights for Pickell Park Field #1 will be turned off at 10:00 PM.
